# Radiocommunications Regulations (General User Radio Licence for Ultra Wide Band Devices) Notice 2015

Pursuant to section 111 of the Radiocommunications Act 1989 and Regulation 9 of the Radiocommunications Regulations 2001, and acting under delegated authority from the Chief Executive of the Ministry of Business, Innovation and Employment, I give the following notice.

#### Notice

**1. Short title and commencement**—(1) This notice is the Radiocommunications Regulations (General User Radio Licence for Ultra Wide Band Devices) Notice 2015.

(2) This notice comes into force on 19 March 2015.

#### 2. Licence-

(1) Licence Name: General User Radio Licence for Ultra Wide Band devices.

(2) Licence: Any person may transmit radio waves using Ultra Wide Band (UWB) devices in

accordance with the applicable terms, conditions and restrictions of this notice.

(3) Licence number: 246809

(4) Commencement date: 15 December 2014.

#### 5. Special conditions—

- 1. The maximum permitted mean power spectral density is -90 dBm/MHz e.i.r.p.
- 2. The maximum permitted mean power spectral density is -85 dBm/MHz e.i.r.p.
- 3. The maximum permitted mean power spectral density is -70 dBm/MHz e.i.r.p.
- 4. The maximum permitted mean power spectral density is -80 dBm/MHz e.i.r.p.
- 5. The maximum permitted mean power spectral density is -41.3 dBm/MHz e.i.r.p.
- 6. The maximum permitted mean power spectral density is -65 dBm/MHz e.i.r.p.
- 7. Low Duty Cycle (LDC):

Within the band 3.1 - 4.8 GHz, devices implementing low duty cycle mitigation techniques are permitted to operate with:

- 1. a maximum mean spectral density of -41.3 dBm/MHz e.i.r.p.; and
- 2. a maximum power of -30 dBW e.i.r.p.
- 8. Road and rail vehicles—
  - 1. For devices installed in road and rail vehicles, where transmit power control is implemented:
    - a. the maximum mean spectral density is -41.3 dBm/MHz e.i.r.p.; and
    - b. the maximum power is -30 dBW e.i.r.p.; and

- c. the transmit power control must operate with a dynamic range of at least 12 dB below the maximum mean e.i.r.p. spectral density.
- 2. For devices installed in road and rail vehicles, where transmit power control is not implemented:
  - a. the maximum mean spectral density is -53.3 dBm/MHz e.i.r.p.; and
  - b. the maximum power is -42 dBW e.i.r.p.

### 6. General conditions applying to all transmissions under this licence—

- 1. The frequency ranges, maximum power of transmissions within those frequencies ranges, and designated uses of frequencies are those prescribed in this licence. All transmissions in a given frequency range must comply with any special conditions relating to that frequency range.
- 2. The maximum power dBW e.i.r.p. is the highest mean radiated power measured in any direction and at any frequency within the defined range within a 50 MHz bandwidth centred on the frequency at which the highest mean radiated power occurs.
- 3. The maximum permitted mean power spectral density e.i.r.p. is the highest signal strength measured in any direction at any frequency within the defined range, where the mean e.i.r.p. spectral density is measured with a 1 MHz resolution bandwidth, an RMS detector and an averaging time of 1ms or less.
- 4. Transmissions are not permitted:
  - 1. on board any aircraft
  - 2. from any fixed outdoor transmitter or antenna.
- 5. Transmitters must conform to technical standards as prescribed in notices under Regulation 32(1)(b) of the Regulations.
- 6. Frequency use is on a shared basis and the chief executive does not accept liability under any circumstances for any loss or damage of any kind occasioned by the unavailability of frequencies or interference to reception.
- 7. Should interference occur to services licensed pursuant to a radio licence or a spectrum licence, the chief executive reserves the right to require and ensure that any transmission or any emission pursuant to this General User Radio Licence change frequency, reduce power or cease operation.
- **7. Consequential revocation of licence**—(1) The Radiocommunications (General User Radio Licence for Ultra Wide Band Communication Devices) Notice 2008, dated the 29th day of July 2008 and published in the <u>New Zealand Gazette</u>, 31 July 2008, No. 119, page 3145, is revoked.
- (2) Notwithstanding the revocation of the notice under subsection (1), every transmitter capable of making transmissions compliant with the requirements of that notice on the commencement date of this notice is deemed to be compliant with the requirements of this notice.

# Ministerial Statement to Accompany the Direction to the Registrar of the New Zealand Emission Unit Register

In making the above direction to the Registrar I have consulted with the Minister of Finance and I have had regard to the following matters specified in section 68 of the Climate Change Response Act 2002:

Section 68(2)(b)(i)

The number of units that New Zealand has received, or that the Minister expects New Zealand to receive, under any international agreement

New Zealand has received 309,564,733 Assigned Amount Units (AAUs) under the Kyoto Protocol. New Zealand has elected to receive removal units for net increases in forest sinks (RMUs) at the end of Commitment Period One (CP1). It is estimated New Zealand will receive 71.6 million RMUs.

New Zealand decided not to take its commitment under the Second Commitment Period. Therefore, New Zealand will not have an assigned amount for Commitment Period Two (CP2).

Section 68(2)(b)(ii)

New Zealand's international obligations, including any obligation to retire units equal to the number of tonnes of emissions that are emitted in New Zealand

Under the United Nations Framework Convention on Climate Change, New Zealand has a commitment to adopt policies and measures to mitigate climate change.

New Zealand also has obligations under the Convention's Kyoto Protocol, whereby it must retire sufficient Kyoto units to cover its total emissions during CP1 or face non-compliance consequences. New Zealand has received 309,564,733 AAUs and expects to receive 71.6 million RMUs. The latest projection of New Zealand's net position under the Kyoto Protocol is a surplus of 127.5 million units.

New Zealand decided not to take its commitment under the Second Commitment Period. Therefore no international obligation to retire New Zealand Units (NZUs) equal to the number of tonnes of emissions that are emitted in New Zealand exists at this stage.

Section 68(2)(b)(iii)

The proper functioning of the greenhouse gas emissions trading scheme established under this Act

The proper functioning of the New Zealand Emissions Trading Scheme (NZ ETS) requires the issuance of sufficient NZUs to meet entitlements of post-1989 forestry participants; any entitlements under an allocation plan; and any auctions of NZUs the Crown undertakes. Officials estimate that over the next two financial years (2014/15, 2015/16), 18.9 million exportable NZUs will be transferred to post-1989 forest land owners and PFSI participants; and 13.9 million non-exportable NZUs will be transferred to industrial allocation recipients, entities with Negotiated Greenhouse Agreements and participants engaged in certain removal activities.

Officials will monitor the balance of NZUs closely to ensure a further issuance, or cancellation of NZUs can occur to maintain the proper functioning of the NZ ETS.
