#### Hazardous Substances (Dichlorvos-Containing Substances Direction Prohibiting Use and Controlling Storage and Disposal) Notice 2015

Pursuant to section 66 of the Hazardous Substances and New Organisms Act 1996 (“the Act”), the Environmental Protection Authority (EPA) issues the following notice.

# **N o t i c e**

**1. Title**—This notice is the Hazardous Substances (Dichlorvos-Containing Substances Direction Prohibiting Use and Controlling Storage and Disposal) Notice 2015.

**2. Commencement**—This notice comes into force 28 days after the date of notification in the *New Zealand Gazette*.

**3. Interpretation**—(1) In this notice, words and phrases have the meanings given to them in the Act and in Regulations made under the Act.

(2) In this notice, the following words have the following meanings:

**Collector** means a person, other than the holder, who collects, transports or stores dichlorvos-containing substances, for the purpose of disposal, in accordance with this notice.

**Decision Report** means the decision report\* for the EPA reassessment application APP202097, lodged under section 63 of the Act.

**Dichlorvos** means dichlorvos (CAS Number 62-73-7).

**Dichlorvos-containing substance** means any of the following substances:

Flammable aerosol containing 3.1 g/litre dichlorvos and 8.7 g/litre propoxur, formerly approved under the Act with approval number HSR000207;

Ready to use liquid containing 4.4 g/litre dichlorvos and 9.6 g/litre propoxur, formerly approved under the Act with approval number HSR000209.

**Environmentally sound disposal** means disposal in accordance with clause 7 of this notice.

**Holder** means a person who is in possession of any dichlorvos-containing substances on or after the date this notice comes into force prior to collection by a collector.

**4. Prohibition on use**—(1) No person may use a dichlorvos-containing substance after the expiry of 15 March 2016.

**5. Controls on use of dichlorvos-containing substances until 15 March 2016**—(1) The controls set out in the Annex to the Decision Report shall apply to the use of a dichlorvos-containing substance from the date of commencement of this notice until the expiry of 15 March 2016.

**6. Storage of dichlorvos-containing substances**—Holders and collectors must ensure that a dichlorvos-containing substance is only stored in suitable containers and kept in buildings and places which are:

(a) secure and suitable for the purpose taking into account the quantities stored, moisture control ventilation and spill containment; and

(b) sited so that the risk of contamination of people, animals, crops and the environment is minimised.

**7. Controls on the disposal of dichlorvos-containing substances**—(1) A dichlorvos-containing substance may be disposed of by:

(a) treating the substance using a method that changes the characteristics or composition of the substance so that the substance or any product of such treatment is no longer a hazardous substance; or

(b) exporting the substance from New Zealand as waste for environmentally sound disposal provided that such export complies with New Zealand law.

(2) In subclause 7(1)(a), treating the substance does not include:

(a) application to or discharge to any environmental medium, save in the case of use of a dichlorvos-containing substance before the expiry of 15 March 2016 in accordance with the controls set out in the Annex to the Decision Report; or

(b) dilution of the substance with any other substance before discharge into the environment; or

(c) depositing the substance in a landfill or a sewage facility; or

(d) depositing the substance in an incinerator unless in doing so the substance is treated in accordance with subclause 7(1)(a).

(3) All stocks of dichlorvos-containing substances must be disposed of by the expiry of 15 March 2016.

**8. Controls on collectors of dichlorvos-containing substances**—(1) A collector must ensure that equipment used to handle the substance complies with Regulation 7 of the Hazardous Substances (Class 6, 8, and 9 Controls) Regulations 2001.

(2) A collector who handles a dichlorvos-containing substance must comply with Regulation 8 of the Hazardous

Substances (Class 6, 8, and 9 Controls) Regulations 2001.

(3) Regulation 9 of the Hazardous Substances (Class 6, 8, and 9 Controls) Regulations 2001 applies to any quantity of a dichlorvos-containing substance.

(4) For the purposes of Regulation 10 of the Hazardous Substances (Class 6, 8, and 9 Controls) Regulations 2001, no dichlorvos-containing substance in any quantity may be carried on any passenger service vehicle.

(5) When stored for the purpose of environmentally sound disposal, a dichlorvos-containing substance must not be mixed with any other substance.

(6) The Hazardous Substances (Packaging) Regulations 2001 apply to the substance "Ready to use liquid containing 4.4 g/litre dichlorvos and 9.6 g/litre propoxur" as if it is deemed to have a hazard classification that is class 6.1D and 9.1A.

(7) The Hazardous Substances (Compressed Gases) Regulations 2004 apply to the substance "Flammable aerosol containing 3.1 g/litre dichlorvos and 8.7 g/litre propoxur" as if it is deemed to have a hazard classification that is class 2.1.2A.

(8) The Hazardous Substances (Classes 1 to 5 Controls) Regulations 2001 apply to the substance "Flammable aerosol containing 3.1 g/litre dichlorvos and 8.7 g/litre propoxur" as if it is deemed to have a hazard classification that is class 2.1.2A.

(9) Transport of dichlorvos-containing substances by land within New Zealand shall comply with all relevant requirements of the Land Transport Rule: Dangerous Goods 2005 (Rule 45001/1).

(10) Transport of dichlorvos-containing substances by sea within New Zealand shall comply with all relevant requirements of either the Maritime Rules: Part 24A – Carriage of Cargoes – Dangerous Goods (MR024A) or the International Maritime Dangerous Goods Code.

(11) Transport of dichlorvos-containing substances by air within New Zealand shall comply with all relevant requirements of Part 92 of the Civil Aviation Rules.

(12) The Hazardous Substances (Tank Wagons and Transportable Containers) Regulations 2004 apply to dichlorvos-containing substances stored or transported in a tank, tank wagon or transportable container as those terms are defined in those Regulations.

(13) The location and movement of dichlorvos-containing substances must be recorded in accordance with the Hazardous Substances (Tracking) Regulations 2001.

(14) The Hazardous Substances (Emergency Management) Regulations 2001 apply to dichlorvos-containing substances as if they are deemed to have the following hazard classifications:

Flammable aerosol containing 3.1 g/litre dichlorvos and 8.7 g/litre propoxur: class 2.1.2A, 6.5B and 9.1A;

Ready to use liquid containing 4.4 g/litre dichlorvos and 9.6 g/litre propoxur: class 6.1D and 9.1A.

(15) The Hazardous Substances (Identification) Regulations 2001 apply to dichlorvos-containing substances as if they are deemed to have the following hazard classifications:

Flammable aerosol containing 3.1 g/litre dichlorvos and 8.7 g/litre propoxur: class 2.1.2A, 6.3B, 6.4A, 6.5B, 6.7B, 6.9B, 9.1A, 9.4C;

Ready to use liquid containing 4.4 g/litre dichlorvos and 9.6 g/litre propoxur: class 6.1D, 6.3B, 6.4A, 6.5B, 6.7B, 6.9B, 9.1A, 9.3B, 9.4C.

## New Zealand Emissions Trading Scheme: Previously Withheld Final Allocations for Eligible Activities

Publication of allocations to eligible industry persons is required by section 86B(5) of the Climate Change Response Act 2002 (CCRA). However, in accordance with section 86B(6)(b), the Chief Executive of the Environmental Protection Authority (EPA) is not required to publish the final allocation of an eligible person for an eligible activity in respect of a year, if the Chief Executive considers that publishing that information would be likely to prejudice unreasonably the commercial position of the eligible person who received the allocation.

A small number of allocation decisions relating to the 2010 and 2011 allocation years were withheld as it was unclear whether publication would unreasonably prejudice the commercial position of some applicants.

The risk of commercial prejudice has been removed with the passage of time and in the interests of transparency and completeness of disclosure, it is now considered by the EPA that this information should be made public.

These New Zealand Units (NZUs) have been allocated to eligible persons to protect their competitiveness against producers that do not face equivalent costs for emissions. The NZUs allocated under these decisions were transferred to the respective New Zealand Emissions Unit Register (NZEUR) holding accounts in 2010 or 2011 as listed.

2. The following equipment will be exempt from the requirements of the Regulations, with effect from 24 September 2015:

Items of mobile plant (including earth-moving equipment), not originally designed as a crane, and used for load lifting incidental to their principal function are entirely exempt from the Health and Safety in Employment (Pressure Equipment, Cranes, and Passenger Ropeways) Regulations 1999 subject to the following conditions as applicable:

1. Lifting points and equipment used for rigging loads are to be certified by a Chartered Professional Engineer; and
2. in the case of new and used hydraulic excavators with an operating weight of seven tonne or more, the following additional conditions apply:
  - a. the equipment is not to be modified to make it operate as a crane other than the provision of a lifting point; and
  - b. the equipment is to have a loading chart available to operators; and
  - c. operators and ground support personnel are to be adequately trained; and
  - d. operations are to be carried out in accordance with the Approved Code of Practice for Load-Lifting – Rigging; and
  - e. except for load-lifting mobile plant used in forestry operations that do not involve the construction of forest roads, hose burst protection valves are required after **1 January 2016**.

## General Section

### Deer Industry New Zealand Levy Rates

1. Deer Industry New Zealand (DINZ) is a marketing authority established by Regulation 4 of the Deer Industry New Zealand Regulations 2004.

2. **DINZ levy**

2.1 Under Regulation 18(1) of the Deer Industry New Zealand Regulations 2004, DINZ fixes the rates of DINZ levy (which levy rates are exclusive of goods and services tax imposed by the Goods and Services Tax Act 1985) as follows:

(a) On venison derived from deer, other than fallow deer, slaughtered in deer slaughtering premises, on the basis of hot clean carcass weight after removal of condemned parts:

19.50 cents (nineteen point five cents) per kilogram for the period 1 October 2015 to 30 September 2016.

(b) On venison derived from each fallow deer slaughtered in deer slaughtering premises, on the basis of hot clean carcass weight after removal of condemned parts:

12.50 cents (twelve point five cents) per kilogram for the period 1 October 2015 to 30 September 2016.

(c) On velvet from deer other than fallow deer received at a packing house for processing or packing, on a frozen weight basis:

325 cents (three hundred and twenty-five cents) per kilogram for the period 1 October 2015 to 30 September 2016.

(d) On velvet from fallow deer received at a packing house for processing or packing, on a frozen weight basis:

90 cents (ninety cents) per kilogram for the period 1 October 2015 to 30 September 2016.

2.2 For the purpose of paragraphs 2.1(a) and 2.1(b) above, hot clean carcass weight is defined in the DeerQA Venison Processors Industry Agreed Standards (dated 21 July 2003) at Standard IAS-3: Venison Standard Carcass. This document is available on request from Deer Industry New Zealand by telephone (04) 473 4500 or mail to PO Box 10702, Wellington.

2.3 The levy rates described in paragraphs 2.1(a) and 2.1(b) above are payable by the owner at the time of slaughter. However, where the venison is sold at the time of slaughter to a venison processor or venison marketer (as defined in Regulation 3 of the DINZ Regulations 2004):

(a) the portions of the levy on such venison that are allocated to TBfree New Zealand (as described in paragraph 9.2 below) shall remain payable by the owner at the time of slaughter;

(b) the remainder of the levy payable on such venison shall be payable in equal shares by the owner at the time of slaughter and the venison processor or venison marketer.

2.4 No levy is payable on velvet when the value of the applicable velvet grade, as defined by the Industry Agreed Grading Guidelines, is less than or equal to \$15.00/kg (GST exclusive).

2.5 If the deer slaughtering premises (DSP) or packing house (PH) (formerly game packing house) fails to keep accurate records relating to the DINZ levy or to file accurate returns relating to the DINZ levy, then the levy payable will be assessed by DINZ with reference to such information as DINZ considers fit.

3. DSPs are not required to collect levies on Tb reactors but will be required to report the number of reactor deer slaughtered to DINZ in their monthly returns. The levy will be waived for those Tb reactors which are identified with an official reactor tag and where they arrive at the DSP accompanied by an official permit to move.

4. A nil rate of levy applies to any farmed deer or killed game deer carcasses which are wholly condemned for any reason following slaughter or receipt into a PH.

5. No levy is payable in respect of any one farmed deer carcass or piece of velvet more than once.

6. These rates of levy come into effect on and from 1 October 2015 and apply until 30 September 2016, or until such time as new levy rates are fixed and come into force.

7. Under Regulation 19, notice is given that DINZ fixes the rate of additional levy payable in respect of failure to pay, or late payment of, amounts of levy payable on or after 1 October 2015 at 10 per cent of the amount of levy unpaid.

8. The additional levy for failure to pay or late payment may be applied by DINZ at a rate of 10 per cent on the outstanding balance following expiration of the period within which payment is required to be received by DINZ, and is payable by the DSP or PH concerned.

9. Of the DINZ levy, a portion will be paid to TBfree New Zealand as the deer industry's contribution to TBfree New Zealand's activities under the national pest management strategy for bovine tuberculosis. A further portion will be paid to NAIT Limited as the deer industry's contribution to the National Animal Identification and Tracing scheme. The DINZ levy will be broken down as follows:

9.1 For Deer Industry New Zealand:

- Venison (fallow) 7 cents per kilogram.
- Venison (other) 14 cents per kilogram.
- Velvet (fallow) 40 cents per kilogram.
- Velvet (other) \$2.75 per kilogram.

9.2 For TBfree New Zealand:

- Venison 5 cents per kilogram.
- Velvet 50 cents per kilogram.

9.3 For NAIT Limited:

- Venison 0.50 cents per kilogram.
