container, in relation to a hazardous substance, means anything in or by which a hazardous substance is wholly or partly encased, covered, enclosed, contained or packed, including anything necessary for the container to perform its function as a container.

importation has the same meaning as in the Act, and **import** has a corresponding meaning.

importer, in relation to a hazardous substance, means a person by or for whom a hazardous substance is imported; and includes the consignee of the hazardous substance and a person who is or becomes the owner of or entitled to the possession of or beneficially interested in the hazardous substance on or at any time after its importation and before it has ceased to be subject to the control of the New Zealand Customs Service.

label, in relation to a hazardous substance, means a group of written, printed, pictorial or graphic information elements concerning a hazardous substance, that is affixed to or printed on, or attached to the immediate container of that hazardous substance, or to the outside of the packaging of the hazardous substance and includes fold-out labels, multilayer booklets and tie-on tags, and **to label** has a corresponding meaning.

manufacture, for the purposes of this notice:

- (a) means make, prepare, produce, label or pack (including packing into a container) a hazardous substance; and
- (b) includes repacking or relabelling a hazardous substance.

manufacturer, in relation to a hazardous substance, means a person who manufactures the hazardous substance.

personal use, in relation to a hazardous substance, means use by an individual in the individual's personal capacity.

prescribed information means the information prescribed in clause 6 of this notice.

(2) Any term or expression that is defined in the Act and used, but not defined, in this notice has the same meaning as in the Act.

Part B: Information requirements

5. Duty of importer or manufacturer to notify Authority

(1) This clause applies when:

- (a) an importer first imports a hazardous substance for the purposes of:
 - (i) supply to another person; or
 - (ii) use by the importer in a workplace; or
- (b) a manufacturer first manufactures a hazardous substance for the purposes of:
 - (i) supply to another person; or
 - (ii) use by the manufacturer in a workplace, other than immediate use.

(2) An importer or manufacturer must notify the Authority of the prescribed information within the 30-day period after the date of importation or manufacture (as the case may be).

(3) There is no need to re-notify the Authority merely because the importer imports, or the manufacturer manufactures, a different hazardous substance at a later time.

(4) For the purposes of subclause (1), the first importation or first manufacture must be treated as meaning the first importation or the first manufacture that occurs after:

- (a) the commencement of this notice; or
- (b) the giving of written notice by the Authority to the importer or manufacturer that the Authority intends to dispose of the prescribed information about the importer or manufacturer that the Authority holds for the purpose of this notice.

(5) This clause does not apply to an individual who imports or manufactures a hazardous substance exclusively for that individual's personal use.

6. Prescribed information

For the purposes of clause 5, the prescribed information is:

- (a) the name of the legal person who is the importer or manufacturer; and
- (b) if different from the name referred to in paragraph (a), the full trading name of the importer or manufacturer; and
- (c) the importer or manufacturer's business address or, if that is not available, residential address, which must, in either case, include a physical address in New Zealand; and
- (d) if the importer or manufacturer maintains a website associated with its business, the website address; and
- (e) contact details for a natural person in New Zealand who is authorised by the importer or manufacturer to act as a contact person, including the person's:
 - (i) name;
 - (ii) email address;
 - (iii) telephone number; and

(iv) relationship to the importer or manufacturer.

7. Purpose for which prescribed information collected

The purpose for which the Authority collects the prescribed information is to assist the Authority to perform or exercise the functions, duties and powers referred to in section 11 of the Act including, but not limited to, the carrying out of its compliance and enforcement functions under the Act.

8. Manner in which prescribed information to be provided

(1) The prescribed information must be notified in a manner and form that is acceptable to the Authority.

(2) The Authority may establish an electronic facility that allows notification to be carried out by electronic means, and may require that notification be carried out by using that electronic facility.

(3) In any case in which the Authority permits or requires notification by post or by an electronic means, and notification is provided by that means, the notice must be treated as having been received by the Authority on whichever is the earlier of:

(a) the date the Authority receives notification; or

(b) five working days after the notification was sent.

9. Duty to maintain accuracy and currency of prescribed information

(1) An importer or manufacturer must promptly notify the Authority of any changes to the prescribed information that are required to make it accurate and current.

(2) For the purpose of allowing the Authority to decide whether it is necessary to continue to hold information about a manufacturer or importer that the Authority has collected under this notice, the Authority may require an importer or manufacturer to advise the Authority whether it has imported or manufactured a hazardous substance within the preceding two years.

(3) Clause 8 applies for the purposes of advising the Authority under this clause.

2. Amendment to principal exemption—Replace clause 3 of the Electricity Industry (Exemption No. 213 (Vector Limited)) Exemption Notice 2014, published in the [New Zealand Gazette, 16 October 2014, No. 127, page 3558](#), (“principal exemption”) with:

“**3. Term**—This exemption expires at the close of **31 October 2016**.”

3. Reasons for this amendment—The reasons for amending the principal exemption are as follows:

- a. the amendment meets the requirements in section 11(3) of the Act for amending exemptions;
- b. the amendment extends an existing mutually agreed solution between Hunet Limited (“Hunet”) and Vector Limited (“Vector”) to enable Hunet to have payment terms that match its billing cycles while maintaining Vector’s financial position;
- c. Vector has undertaken to:
 - i. ensure that the total value of additional security specified in the use-of-system agreement must be such that the total value of all security required to be provided by Hunet is no more than Vector’s reasonable estimate of the line function services charges that Hunet will be required to pay to Vector in respect of any three-month period;
 - ii. provide Hunet with an extension of the time it has to pay Vector’s line services by a one-month period;
 - iii. pay charges for the security provided by Hunet as specified in clause 12A.5(3) of the Electricity Industry Participation Code 2010 (“Code”); and
 - iv. consider options for transition to standard contract terms and Code compliance within the twelve-month period of the exemption. Where mutually agreed between Hunet and Vector, security may be lowered, and time to pay may be reduced commensurate to each other, to allow Hunet to easily transition to normal payment terms; and
- d. the amendment will have little or no impact on other participants and service providers, and will not affect any other Code provisions.

Variable Speed Limit—Christchurch Northern Motorway, State Highway 1

Pursuant to clause 6.1 of Land Transport Rule: Setting of Speed Limits 2003 and a delegation from the NZ Transport Agency, I, Glenn Bunting, Network Manager, approve a variable speed limit on the southbound section of the Christchurch Northern Motorway, State Highway 1, in accordance with the conditions set out in this notice.

Conditions

1. Variable Speed Limit

The NZ Transport Agency may set a variable speed limit of 60km/h on the section of State Highway 1 described in condition 2 of this notice. The variable speed limit may be used to manage the safety of road users and the efficient flow of traffic due to traffic congestion, in emergency circumstances or during road works.

2. Section of State Highway

A variable speed limit may be set on the southbound section of the Christchurch Northern Motorway, State Highway 1, from the Ohoka Road over-bridge at Kaiapoi to 120 metres north of the intersection with Main North Road and Dickeys Road, at Belfast.

3. Signs

Speed limit signs that comply with Land Transport Rule: Traffic Control Devices 2004 must be installed as follows:

- (a) two “Variable speed” (R1-2.1) signs (one sign adjacent to each lane) facing road users travelling south, to notify them when the variable speed limit is operating:
 - (i) at the northern end of the variable speed limit;
 - (ii) at additional locations within the section of State Highway 1 described in condition 2 of this notice, with a spacing of no more than 2.0km between sign locations;
- (b) two “Standard” (R1-1) speed limit signs facing road users travelling south and leaving the variable speed limit, to notify them of the permanent speed limit beyond that point:
 - (i) at the southern end of the variable speed limit;
 - (ii) on each off-ramp leaving the section of State Highway 1 described in condition 2 of this notice;
- (c) at least one “Variable speed” (R1-2.1) sign facing road users on each onramp joining the section of State Highway 1 described in condition 2 of this notice, to notify them when the variable speed limit is operating.

4. Speed Limit May Apply to Part of the Road

The variable speed limit may apply to the entire section of State Highway 1 described in condition 2 of this notice or may apply to part of that section only, extending north from Belfast in consecutive lengths of road bounded by the location of the variable speed limit signs.

5. Speed Limit Displayed on Signs

The variable speed limit that applies to a length of road at any time must be displayed on the variable speed limit signs within that length of road. When the permanent speed limit for the road applies, the variable speed limit signs must be blank.

6. Recording Changes of Speed Limit

Records must be kept to show the actual speed limit applied to any particular length of road at any time. The records must be available for public inspection and include the time the speed limit changed, the date, the speed limit and a description of the beginning and end points of the length of road to which the speed limit applied.

7. Bylaw

The NZ Transport Agency must set the variable speed limit by making a bylaw in accordance with Land Transport Rule: Setting of Speed Limits 2003.

Exemption for Patrick Clifford Strange Under Section 90(1)(b) of the Electricity Industry Act 2010

 - i. the selection of, and any negotiation with, any electricity retailer for the supply, or intended supply, of electricity to AIAL; and
 - ii. the supply, or intended supply, of electricity by MRPL to any new or existing consumer on AIAL’s electricity distribution network;
- b. Dr Strange must not disclose the outcome of any discussions or decision-making by AIAL to MRPL (and vice versa) on the matters referred to in paragraph (a).

(2) Dr Strange must confirm to the Authority, in writing, that the cross-directorship to which this exemption relates has ceased within one calendar month of the cross-directorship ceasing to exist.

(3) The exemption is specific to the cross-directorship created through Dr Strange’s involvement in AIAL and MRPL. It does not extend to any other interest or future cross-involvement of Dr Strange.

3. Commencement—This exemption comes into force on the date it is notified in the *New Zealand Gazette*.

Should the project not proceed and the status quo remain, the decline in the health of the Ongatoro/Maketu Estuary, which is currently highly degraded, will continue.

There have been calls from the community to re-divert the Kaituna River into the Estuary for decades. The Council has spent nearly 15 years considering over 15 options for a full re-diversion or partial re-diversion of the Kaituna River. By an iterative process, the Council decided that the project best met the objectives of the Kaituna River and Ongatoro/Maketu Estuary Strategy in respect of costs and scale of benefits derived, taking into account feedback from landowners, tangata whenua, stakeholders, and the community.

The land will be used:

- a. for widening Fords Cut;
- b. for environmental enhancement, including establishment of wetlands on low-lying lands;
- c. for site establishment activities and services relocation, to allow for the removal of stopbanks around the land north of Fords Cut and the causeways in the upper estuary currently blocking flow in the estuary; and
