## Land Transport Rule: Traffic Control Devices 2004 - Directional Cycle Traffic Signals Trial

Pursuant to subclause 3.4(1) of the Land Transport Rule: Traffic Control Devices 2004 ("Rule") and a delegation from the NZ Transport Agency, I, Glenn Bunting, Network Manager, authorise the installation and maintenance of directional cycle traffic signal displays, incorporating a cycle symbol and an arrow, to control the movement of cycle traffic in different directions at different times:

- a. for the purpose described in Schedule 1;
- b. in the form and layout set out in Schedule 2;
- c. at the locations stated in Schedule 3;
- d. for the period specified in Schedule 4; and
- e. subject to the evaluation outlined in Schedule 5.

The directional cycle traffic signal displays may be installed for the purpose of evaluating their use and the trial will be called the "directional cycle traffic signals trial".

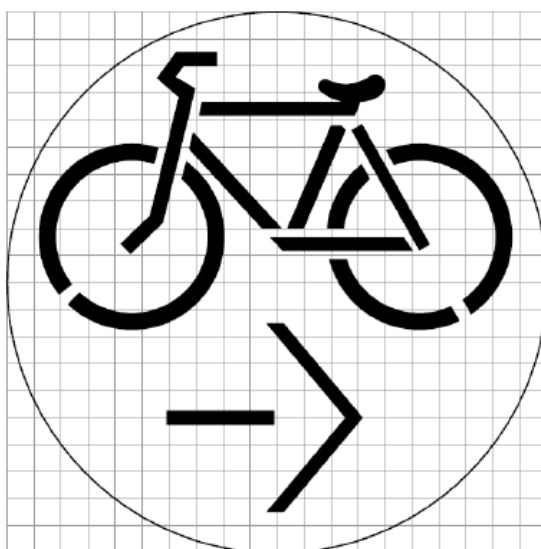
### Schedule 1—Purpose of trial

The purpose of the trial is to:

- a. Enable the installation of directional cycle traffic signal displays that incorporate an arrow in the same signal aspect with the cycle symbol, as an alternative to the requirements for traffic signal displays in 6.3(1)(a), 6.4(1) and Schedule 3 of the Rule;
- b. evaluate the safety and effectiveness of traffic signal displays that allow cyclists on the same approach to an intersection to move in different directions at different times; and
- c. assess cyclists' and other road users' understanding of and compliance with traffic signals that control directional movement of cyclists at intersections with cycle traffic signals.

#### **Schedule 2—Form and layout of directional cycle traffic signals**

- a. Each red, yellow and green directional cycle traffic signal display must comprise a cycle symbol above an arrow to indicate the controlled movement;
- b. directional cycle traffic signal displays must be at least 200mm diameter;
- c. the sequence of directional cycle traffic signals must comply with 6.4(3) of the Rule;
- d. the operation of the signals must comply with clauses 6.4(4)-6.4(8) of the Rule; and
- e. directional cycle traffic signals may only be installed at an intersection in conjunction with standard displays of traffic signals for vehicles.



**Example: Directional cycle traffic signal display.**

*Note:* The example directional cycle traffic signal display is conceptual only and is not intended to be the design standard used for the trial.

#### **Schedule 4—Period of trial**

The trial may begin after 1 July 2017 and, unless terminated earlier, must end by 30 June 2019.

#### **Schedule 5—Evaluation**

An evaluation and analysis must be undertaken and reports prepared as described in the trial application dated February 2017, received from the Christchurch City Council. The evaluation must include:

- a. Measurement of cyclists' compliance with the directional cycle signals;

- b. measurement of other road users' compliance with the traffic signals at intersections where directional cycle signals are installed;
- c. assessment of road users' recognition and understanding of the displays used for directional cycle signals;
- d. analysis of conflicts and crashes;
- e. an outline of costs, efficiency improvements and other benefits;
- f. a summary of feedback received from cyclists, and the general public during the trial;
- g. a description of any operational issues which arose during the trial and how they were resolved; and
- h. recommendations for improvements or changes that should be made to the operation, form or layout of directional cycle traffic signals.

An interim evaluation report must be sent to me by 28 February 2018 and a final report by 31 August 2019.

### Amendment to Constitution in Te Pa o Rakaihautu Establishment Notice

Pursuant to section 156AA(6)(c) of the Education Act 1989, with authority delegated from the Minister of Education, the notice for Te Pa o Rakaihautu Establishment published in the [New Zealand Gazette, 27 February 2014, No. 24, page 716](#), is amended by replacing the section headed “Constitution of the Establishment Board of Trustees” with the following text:

#### “Constitution of the Board of Trustees

1. Te Pā o Rākaihautū School (706) Board of Trustees (known as Te Tautarinui o Matariki o Te Pā o Rākaihautū Board of Trustees — Te Tautarinui) shall be made up of the following members who are full members of the board with equal voting rights and full responsibility and accountability requirements:

- a. the Kaiurungi (Principal) of Te Pā o Rākaihautū;
- b. up to five members to be appointed by the Nōku Te Ao Charitable Trust;
- c. two whānau representatives to be selected following the process set out in this notice;

- d. up to four members co-opted by Te Tautarinui on the basis of particular experience, expertise, skill and/or leadership that in the opinion of Te Tautarinui will assist in advancing the kaupapa of Te Pā o Rākaihautū.

2. All appointments, selections and co-options to Te Tautarinui are to be made on the basis of knowledge of the kaupapa of Te Pā o Rākaihautū and in accordance with the position description and skills-based matrix approved by Te Tautarinui.

3. The term of office for all selected, appointed or co-opted members shall be a maximum of 3 years.

*Selection of Whānau representatives*

4. Whānau are parents or caregivers of students, other than adult students, enrolled in Te Pā o Rākaihautū. The selection of whānau representatives to Te Tautarinui shall be by way of a hui managed by Te Pae Kōkōraki.

5. Te Pae Kōkōraki will be appointed by Te Tautarinui and will comprise three members who shall not be:

- a. a current trustee;
- b. a candidate for selection;
- c. a Te Pā o Rākaihautū staff member;
- d. a trustee of Nōku Te Ao Charitable Trust;
- e. the Kaiurungi; or
- f. a pononga (student).

6. Te Pae Kōkōraki shall convene a meeting of parents and caregivers of enrolled students (hui Whānau) to:

- a. explain the nomination and selection process including applicable dates; and provide information on the eligibility criteria under the Education Act 1989, and the skills and knowledge matrix developed by Te Tautarinui; and
- b. invite attendees to submit nominations at the hui or in writing to be lodged with Te Pā o Rākaihautū office within 14 calendar days of the hui being called. All nominations shall be displayed at Te Pā o Rākaihautū office and/or made publicly available to whānau.

7. Employees of Te Tautarinui or staff of Te Pā o Rākaihautū who are also parents/caregivers of an enrolled pononga may nominate, or be nominated as, a candidate for a whānau representative trustee position.

8. Te Pae Kōkōraki shall shortlist nominees and hold hui whakawhanaunga (interviews) with each shortlisted nominee, and their whānau tautoko (support) within 20 working days from the date that nominations closed. This process reflects the special tikanga of Te Pā, which relies on a referral-based system for introducing trustees, staff and whānau into Te Pā o Rākaihautū.

9. Te Pae Kōkōraki will apply the applicable eligibility criteria and the position description and skills and knowledge-based matrix approved by Te Tautarinui in assessing eligibility of nominations for the shortlist and for the final selections.

10. Te Pae Kōkōraki shall then select the whānau representatives and notify the results to the chairperson. The new trustees shall take office from the date of the first meeting of Te Tautarinui following notification of the results to the chairperson.

11. The hui whānau and the hui whakawhanaunga shall be run by Te Pae Kōkōraki.

12. Te Pae Kōkōraki is also responsible for:

- a. establishing the list of pononga enrolled in Te Pā o Rākaihautū and the list of their parents/caregivers, and ensuring all the parents/caregivers participating in the hui are eligible to do so;
- b. notifying the parent and school community at least 14 days in advance of the details of any relevant hui;
- c. keeping a list of those who attend any hui;
- d. ensuring that nominees have confirmed in writing that they accept the nomination and are not ineligible to be trustees under sections 103 and 103A of the Education Act 1989;



- e. notifying the incumbent Te Tautarinui, the Secretary for Education and the public of those who have been selected as whānau representatives on Te Tautarinui; and
- f. completing the whānau representative selection process within 40 working days from the date of the whānau hui referred to in clause 6 above.

*Transitional arrangements replacing the Establishment Board of Trustees*

13. The Minister of Education, under section 101(7) of the Act, will, by notice in the *New Zealand Gazette*, fix the date of the first board meeting for trustees selected, appointed or co-opted to Te Tautarinui under this notice.

14. The Establishment Board of Trustees of Te Pā o Rākaihautū shall:

- a. appoint Te Pae Kōkōraki to fix dates for the initial whānau and hui whakawhanaunga to select whānau representatives. The whānau representatives must be selected prior to the date of the first board meeting set under section 101(7) of the Act;
- b. notify the date of the first board meeting to the Nōku Te Ao Charitable Trust, which may appoint up to five trustees prior to that date; and
- c. leave office at the end of the day before the date of the first board meeting set under section 101(7) of the Act.

15. The first whānau representatives and members appointed by the Nōku Te Ao Charitable Trust under these transitional arrangements shall take office on the date of the first board meeting set under section 101(7) of the Act, and Te Tautarinui may co-opt members from that date. The term of office for all Te Tautarinui members during the transitional period will end on the last date gazetted by the Minister for the 2019 triennial elections for schools. Casual vacancies for whānau representatives occurring during the transitional period will be managed using the process set out in clause 18.

*Term of office of members appointed, selected or co-opted to Te Tautarinui after the transitional period*

16. Each term of office for trustees selected by Te Pae Kōkōraki, co-opted by Te Tautarinui or appointed by the Nōku Te Ao Charitable Trust after the transitional period shall be for a period not exceeding three years. Eligible trustees may be reappointed, reselected or co-opted for further terms not exceeding three years. Te Tautarinui resolution co-opting a trustee, or a Nōku Te Ao Charitable Trust appointment, may specify a shorter term of office.

17. From 2019 the term of each board will end on the last date of the range of dates gazetted by the Minister of Education for school board of trustee triennial elections. In an election year each new board will take office on the day after the previous board leaves office.

*Casual vacancies*

18. If a casual vacancy for a whānau representative position arises prior to 6 months of the expiry of the term of that position, then Te Tautarinui must, within six weeks of the position becoming vacant:

- a. resolve to select another eligible person to fill the vacancy using in the first instance the unsuccessful short-listed candidates from the most recent nominations if those nominees remain available and/or eligible; or
- b. if required due to a lack of available nominees, appoint and reconvene Te Pae Kōkōraki to undertake the process of selection set out in this notice;

19. The term of office for the replacement trustee shall start on the date they are selected and be for the remainder of the term of the vacating trustee.

20. Changes to the constitution of Te Pā o Rākaihautū Board of Trustees will be subject to the approval of the Minister of Education and must be notified in the *New Zealand Gazette*."

This notice shall come into force on the date of its publication in the *New Zealand Gazette*.

**Taupo District Trout Fishery Licences, Fees and Forms Notice 2017**

Pursuant to section 48A(2A) of the Conservation Act 1987, and section 14(11) of the Maori Land Amendment and Maori Land Claims Adjustment Act 1926, the Minister of Conservation, with the concurrence of the Tuwharetoa Maori Trust Board, gives the following notice.

**Notice**

**1. Title**—This notice is the Taupo District Trout Fishery Licences, Fees and Forms Notice 2017.

**2. Commencement**—This notice comes into force on **1 July 2017**.

**3. Interpretation**—In this notice, unless the context otherwise requires:

**24-hour licence** means a licence that entitles the holder to take trout within the Taupo District (except at the Tongariro National Trout Centre) during any 24-hour period that is stated in the licence.

**adult** means a person aged over 18 years on 1 July, being the first day of the 12-month period, beginning on 1 July and ending on 30 June, that is stated in the licence.

**child** means a person who is aged under 18 years on 1 July, being the first day of the 12-month period, beginning on 1 July and ending on 30 June, that is stated in the licence.

**Director-General** means the Director-General of Conservation.

**family** means:

- a. one person, or one person and that person's spouse or partner; and
- b. the dependants of that person or those persons who:
  - i. ordinarily or periodically reside with that person or those persons; and

- ii. are aged under 18 years on 1 July; and
- c. the grandchildren of that person or those persons, who are aged under 18 years on 1 July, being the first day of the 12-month period, beginning on 1 July and ending on 30 June, that is stated in the licence.

**family licence** means a licence that entitles the holder and the holder's spouse or partner and, if any member of the holder's family is accompanied by the holder or the holder's spouse or partner, the member of the holder's family, to take trout within the Taupo District (except at the Tongariro National Trout Centre) during the 12-month period, beginning on 1 July and ending on 30 June, that is stated in the licence.

**non-resident** means a person who is neither a New Zealand citizen nor a permanent resident (as those terms are defined in section 4 of the Immigration Act 2009).

**non-resident licence** means a licence that entitles the holder to take trout within the Taupo District (except at the Tongariro National Trout Centre) during the 12-month period, beginning on 1 July and ending on 30 June, that is stated in the licence.

**senior** means a person who is aged 65 years or older on 1 July, being the first day of the 12-month period, beginning on 1 July and ending on 30 June, that is stated in the licence.

**supervisor adult** means an adult who supervises a child who undertakes authorised fishing activities in the children's fishing pond at the Tongariro National Trout Centre.

**Taupo District** means the district described in the Schedule of the Taupo District Order 1983.

**Tongariro National Trout Centre licence** means a licence that entitles the holder (either a child or a supervisor adult) to fish for trout at the Tongariro National Trout Centre, during the period that is stated in the licence.

**trout** includes char of any species, and any hybrid of any trout or char; and includes any trout whether alive or dead, and any part of a trout.

**week licence** means a licence that entitles the holder to take trout within the Taupo District during the period of 7 consecutive days that is stated in the licence.

**whole-season** means the 12-month period beginning on 1 July and ending on 30 June.

**whole-season licence** means a licence that entitles the holder to take trout within the Taupo District (except at the Tongariro National Trout Centre) during the 12-month period, beginning on 1 July and ending on 30 June, that is stated in the licence.

#### *Licences and fees*

**4. Director-General may issue licences**—The Director-General may issue one or more of the following classes of licence:

- a. 24-hour licence.
- b. Tongariro National Trout Centre licence.
- c. Week licence.
- d. Family licence.
- e. Whole-season licence.
- f. Senior licence.
- g. Non-resident licence.

**5. 24-hour licence**—If the Director-General issues 24-hour licences, an adult or a child may apply to obtain a 24-hour licence from the Director-General on payment of the appropriate fee set out in Part 1 of the Schedule and the Director-General may grant or decline such a licence.

**6. Tongariro National Trout Centre licence**—(1) If the Director-General issues Tongariro National Trout Centre licences, a supervisor adult may apply to obtain a Tongariro National Trout Centre licence from the Director-General on payment of the appropriate fee set out in Part 4 of the Schedule and the Director-General may grant or decline such a licence.

(2) If the Director-General issues Tongariro National Trout Centre licences, a child may apply to obtain a Tongariro National Trout Centre licence from the Director-General on payment of the appropriate fee set out in Part 4 of the Schedule and the Director-General may grant or decline such a licence.

**7. Week licence**—If the Director-General issues week licences, an adult resident or an adult non-resident, as the case may be, may apply to obtain a week licence from the Director-General on payment of the appropriate fee set

out in Part 2 of the Schedule and the Director-General may grant or decline such a licence.

**8. Family licence**—If the Director-General issues family licences, an adult may apply to obtain a family licence for the whole-season from the Director-General on payment of the appropriate fee set out in Part 3 of the Schedule and the Director-General may grant or decline such a licence.

**9. Senior licence**—If the Director-General issues senior licences, an adult may apply to obtain a senior licence for the whole-season from the Director-General on payment of the appropriate fee set out in Part 3 of the Schedule and the Director-General may grant or decline such a licence.

**10. Non-resident licence**—If the Director-General issues non-resident licences, an adult may obtain a non-resident licence for the whole-season from the Director-General on payment of the appropriate fee set out in Part 3 of the Schedule and the Director-General may grant or decline such a licence.

**11. Whole-season licence**—If the Director-General issues whole-season licences, an adult or a child may obtain a whole-season licence from the Director-General on payment of the appropriate fee set out in Part 3 of the Schedule and the Director-General may grant or decline such a licence.

**12. Fees inclusive of GST**—The fees set out in the Schedule are inclusive of goods and services tax.

#### *Forms*

**13. Forms of licences**—Every licence issued under this notice must be in writing and must state:

- a. the holder's full name, postal address, and date of birth;
- b. whether the holder is an adult or a child;
- c. the class and effect of the licence;
- d. the time and date of issue; and
- e. the period during which the licence authorises the taking of trout.

**14. Revocation**—The Taupo District Trout Fishery Licences, Fees, and Forms Notice 2011 (SR 2011/202) is revoked.

## Anglers Notice for Taupō District 2017

Pursuant to sections 26R(3) and 53(4) of the Conservation Act 1987 and the Taupō Fishery Regulations 2004, the Minister of Conservation approves the following Anglers Notice for the Taupō Fishery.

### Notice

This notice shall come into force on **1 July 2017**.

**1. Interpretation**—(1) Words and expressions in this notice which are defined in the Conservation Act 1987, the Taupō Fishery Regulations 2004 or the Taupō District Trout Fishery Licences Fees and Forms Notice 2011 shall be so defined.

(2) In this notice, unless the context otherwise requires:

**artificial fly** includes any lure of feather, fur, wool, or other material used in the making of artificial flies.

**bait** means natural bait, including any insect or spider, worm, crustacean, shellfish, fish or fish ova, bread or cheese, or any scented lure, soft bait or other artificial lure with chemical attractant properties.

**boat** means any manned floatation device.

**fly fishing** means to fish for trout with a fly rod, fly reel, fly line, leader, and artificial fly or flies.

**fly line** means any floating or sinking line used to facilitate casting that is at least three metres in length.

**foul hook** means to hook a trout otherwise than through the mouth.

**landmark post** means a white, black, and yellow ringed post.

**leader** means the nylon, fluorocarbon or other material attached directly to the end of the fly line. It must not exceed six metres in length including tippet.

**length**, in relation to a trout, means the total length from the tip of the snout to the fork of the tail of the fish.

**lure** means any artificial fly or spinner.

**spin fishing** means to fish for trout with a spinning rod, spinning reel, and lure, and includes tackle customarily used for harling, trolling, and jigging for trout.

**spinner** means any artificial lure other than an artificial fly.

**strike indicator:**

- means any synthetic or natural yarn, and its means of attachment to the line or cast, used by the person fishing as an aid to detect a strike; but
- does not include:
  - any other material or any object attached to the line or cast; or
  - any synthetic or natural yarn to which has been added any material or chemical (other than a colour dye or surfactant line floatant preparation).

**Taupō Boat Harbour** means that part of the Waikato River lying between a straight line between the two landmark posts on either side of the outlet of Lake Taupō, and the control gates bridge over the Waikato River at Taupō.

**trout** includes:

- any trout, whether alive or dead, and any part of a trout;
- carcass of any species; and

c. any hybrid of any trout or char.

**2. Authorised methods**—(1) The only authorised methods for fishing for trout in the Taupō District are:

- a. fly fishing; and
- b. spin fishing.

(2) No person fishing for trout shall use in any water specified in the Schedule any fishing method other than a method specified in the Schedule for that water.

(3) No person shall attempt to foul hook any trout.

(4) Any person who foul hooks a trout shall return it immediately to the water with as little injury as possible.

(5) No person shall fish for trout when wearing or using felt-soled waders or footwear incorporating or having attached a sole of felted, matted or woven fibrous material.

(6) No person shall fish for trout from:

- a. the Taupō Boat Harbour wharf or Taupō Boat Harbour jetties;
- b. the control gates bridge over the Waikato River at Taupō; or
- c. the bridge over the Tokaanu Tailrace Canal which is part of State Highway 41.

**3. Authorised tackle**—(1) No person may use bait when fishing for trout in the Taupō District.

(2) When playing a trout, a person may use a landing net to secure or land that fish.

(3) No person when fishing for trout shall:

- a. take trout by any means other than with one rod and running line;
- b. use a gaff to secure or land a trout;
- c. use any net, trap, wire netting, or similar device, except as provided for in subclause (2) of this clause;
- d. use any spear or similar implement, or spear gun;
- e. use any hook which has a distance greater than 14mm between the point and the shank;
- f. use any lure having attached to it more than one hook or a hook that is not a single-pointed or single-barbed hook;
- g. use more than three lures;
- h. use any fish-attracting electronic device;
- i. use any lure treated with any fish attractant or chemical preparation other than that used solely to control the buoyancy of an artificial fly; or
- j. use any preparation not attached to a lure to attract fish.

(4) No person fishing for trout in waters reserved for fly fishing (as set out in the Schedule) shall add to or attach to any fly line, leader, or fly:

- a. any bare hook, spinner or bait;
- b. anything made from lead, glass, plastic, or other material to facilitate casting or to increase the buoyancy of the line; or
- c. any sinker or other weight,

but may attach a strike indicator and may add weight to the leader to facilitate sinking. Weight added to the leader may only be in the form of split shot made from lead, bismuth or tungsten.

**4. Daily bag limits**—(1) The maximum number of trout that may be taken from waters in the Taupō District by one person in a single day (the daily bag limit) is as set out in the Schedule.

(2) No person shall on any one day take and keep more than the daily bag limit for trout, and no person shall continue to fish on any day on which he or she has already taken and kept the daily bag limit for trout.

**5. Minimum fish length to be taken**—(1) The minimum length of trout that may be taken from waters in the Taupō District is set out in the Schedule.

(2) A person taking a trout of a length less than that set out in the Schedule must, whether it is alive or dead, immediately return it into the water from which it was taken.

(3) For the purpose of clauses 2(4) or 4(2) or 5(2), any person who takes a trout and fails to return that trout immediately to the water from which it is taken is deemed to have taken and kept that trout.

**6. Hours of fishing**—(1) No person shall fish for trout between 12.00am midnight and 5.00am on any day.

**7. Open season**—(1) No person shall fish for trout in any waters in the Taupō District except during an open season for those waters.

(2) The open season for waters in the Taupō District is as set out in the Schedule, except where a closed season is specified in clause 8.

(3) If any waters are included in both the Schedule and clause 8, clause 8 takes priority and a closed season will be in place for those waters as set out in that clause.

**8. Closed season**—(1) A closed season is in place for the following waters, and no person shall fish for trout in any of these waters at any time of the year:

- a. all rivers and streams (including their tributaries) flowing into Lake Taupō other than the rivers and streams listed in Part B of the Schedule;
- b. all tributaries of the rivers and streams listed in Part B of the Schedule;
- c. Tokaanu Tailrace Canal for a distance of 110m downstream from the powerhouse;
- d. that portion of the Waiotaka River (Stream) that lies wholly within the boundaries of the Tongariro/Rangipo Prison (from approximately 2km upstream of the Hautu Ford on Waiotaka Road to the north-western boundary of Kaimanawa Forest Park);
- e. Te Whaiau Stream and its tributaries (including the Whanganui River diversion culvert outfall) and all other streams (including their tributaries) flowing into Lake Te Whaiau;
- f. all rivers and streams (including their tributaries) flowing into Lake Ōtamangakau other than the Ōtamangakau Canal; and
- g. all rivers and streams (including their tributaries and including Poutu Aqueduct) flowing into Lake Rotoaira except the Wairehu Canal.

(2) A closed season is in place, and no person shall fish for trout at any time of the year within:

- a. any waters in which trout are held in captivity for display, hatching, monitoring or other purposes; or
- b. a distance of 80m from those waters.

(3) Subclause (2) of this clause does not apply to authorised fishing activities held in the children's fishing pond at the Tongariro National Trout Centre.

**9. Use of boats**—(1) No person shall fish for trout from a boat in those portions of Lake Taupō within 200m of a landmark post or posts situated at the mouth or mouths of any river or stream listed in Part A of the Schedule.

(2) Despite subclause (1) of this clause, a person may fish for trout from a boat in those portions of Lake Taupō within 200m of a landmark post or posts situated at the mouth or mouths of the following rivers if the boat is securely anchored parallel to the flow with not more than two anchors:

- a. Tongariro River; and
- b. Tauranga Taupō River.

(3) No person shall fish for trout from a boat in Lake Taupō within 200m of Te Rae Point (known as Kuratau Spit), located approximately 780m south of the mouth of the Kuratau River and marked by a landmark post, unless the boat is securely anchored with not more than two anchors.

(4) In waters other than Lake Taupō, no person shall fish for trout from a boat in waters where only fly fishing is permitted unless the boat is securely anchored parallel to the flow with not more than two anchors.

(5) No person shall fish for trout from a boat in the following places:

- a. the Taupō Boat Harbour;
- b. that portion of the Hinemaiaia Stream (or River) which lies between Lake Taupō and the lower hydro-electric dam (known as the HB Dam);
- c. that portion of the Tongariro River upstream of a point at the head of that stretch of water known as Downs Pool (situated downstream approximately 3.1km in a straight line from the bridge carrying State Highway 1

over the Tongariro River at Turangi) which is normally marked by a landmark post;

d. Lake Te Whaiau;

e. that portion of the Ōtamangakau Canal, also known as Te Whaiau Canal, which flows from Lake Te Whaiau to Lake Otamangakau, upstream of the site normally marked by a landmark post; and

f. that portion of the Wairehu Canal, which flows from Lake Ōtamangakau to Lake Rotoaira, downstream of the site normally marked by a landmark post.

(6) No person shall fish for trout from a boat in the Tokaanu Tailrace Canal unless the boat is securely anchored parallel to the flow with not more than two anchors.

**10. Revocation**—(1) The Anglers Notice for Taupō District, published in the [New Zealand Gazette, 27 May 2016, Issue No. 47, Notice No. 2016-gs2622](#), is revoked.

(2) The Amendment to the Anglers Notice for Taupō District, published in the [New Zealand Gazette, 27 May 2016, Issue No. 77, Notice No. 2016-gs5077](#), is revoked.
